- -Hidden Pennie's did get us a YTD report from last year. But they have been really slow in getting the information we have requested and communication is not great. Report was not separated into the 3 different accounts, it was all lumped together: Vote on do we want to look into a new bookkeeper?
- -Need approval to spend the money for concessions for theater- put to a vote.
- -Could we advertise open board positions at the Thrift Shop?

Operational Vice President:

-Mini Clubs- need POCs POCs track attendance and send names to Katie any which way!

Operational Treasurer:

-Insurance Update? We have business insurance. \$475 a year to cover ops and welfare. Policy: 3/4 will cover thrift shop, so thrift shop will spend 3/4 of \$475 and ops will pay the other 1/4. We need to see if the movie theater will need a new policy separate from the thrift shop/movie theater duo. Sit down with agent/adjustor? Ask legal?

-Looking at ordering shirts and sweatshirts to sell. Need fundraiser request put in, unless we are only selling at membership events (for us by us = no request needed). Reached out to local screen printer. Get a quote from arts and crafts.
